



How to identify a project?

Any floor that is exposed to an industrial process of any kind is a great setting for Alfagres' Industrial Quarry. We have experience in the food and beverage industry such as dairy, meat processing, beer, wine; as well as restaurant kitchens and settings where freezing temperatures are required.

To be able to know what technical specifications are needed, identify what type of industry the installation is in, what substances or chemicals are used in each step of the process and how much weight is the floor submitted to (transport or impact gear). Evaluate each phase in the industry process to specify product and needs for specific areas.

What if it's a pre-existing installation?


Knowledge of the industrial process is of great importance when changing an existing floor. Proper planning of installation will help reduce inconveniences of operational businesses. Evaluate actual floor condition: tile, grout, floor substrate (concrete plate); flaws will give you an idea of where the weak points are.





Common problems with industrial floors

Cracks or holes on actual tile may be due to poor mechanical resistance. Tile and grout can be cracked because of chemical attack and this might affect the concrete plate or substrate. Many times this leads to bad odors because of decomposition of cement. Bad adherence of floor to substrate and a bad draining system may cause the floor to pop up.


Installation

Make sure floor levels and slopes are correct before installing ALFAGRES' quarry tile. Professional installation is of utmost importance; knowledge and skill to handle and store material in a correct manner will decrease breakage normal to material handling.

The grout selection is determined by the industrial process that the floor will be exposed to. An epoxy grout may be used according to the exposure to chemicals or acids (could be milk, sugar, etc) in the industrial process.
